## DRINKING WATER WARNING

Lake of the Woods Mutual Water Company water has high levels of nitrate

DO NOT GIVE THE WATER TO
INFANTS UNDER 6 MONTHS OLD OR PREGNANT WOMEN
OR USE IT TO MAKE INFANT FORMULA

To prevent water outages in the distribution system, Lake of the Woods Mutual Water Company is using the new well (Well 7) that was placed into service February 9, 2016, to supply domestic water. A water sample collected on February 11, 2016, from Well 7, showed nitrate level of 16 milligrams per liter (mg/L as nitrogen). Another water sample collected on March 10, 2016, from Well 7, showed nitrate level of 15 mg/L (as nitrogen). These results are above the nitrate standard or maximum contaminant level (MCL), of 10 mg/L (as nitrogen). Nitrate in drinking water is a serious health concern for infants less than six months old.

#### What should I do?

- DO NOT GIVE THE WATER TO INFANTS. Infants below the age of six months
  who drink water containing nitrate in excess of the MCL may quickly become
  seriously ill and, if untreated, may die because high nitrate levels can interfere
  with the capacity of the infant's blood to carry oxygen. Symptoms include
  shortness of breath and blueness of the skin. Symptoms in infants can develop
  rapidly, with health deteriorating over a period of days. If symptoms occur, seek
  medical attention immediately.
- PREGNANT WOMEN SHOULD NOT CONSUME THE WATER. High nitrate levels may also affect the oxygen-carrying ability of the blood of pregnant women.
- Water, juice, and formula for children <u>under six months of age</u> should not be prepared with tap water. Bottled water or other water low in nitrates should be used for infants until further notice.
- **DO NOT BOIL THE WATER.** Boiling, freezing, filtering, or letting water stand does not reduce the nitrate level. Excessive boiling can make the nitrates more concentrated, because nitrates remain behind when the water evaporates.

• If you have other health issues concerning the consumption of this water, you may wish to consult your doctor.

## What happened? What is being done?

Nitrate in drinking water can come from natural, industrial, or agricultural sources (including septic systems, storm water run-off, and fertilizers). Levels of nitrate in drinking water can vary throughout the year. We will let you know if the amount of nitrate is again below the limit.

A blending tank will be installed to be able to blend the water from Well 7 with other wells. We anticipate completing that before May 2016. Lake of the Woods Mutual Water Company will notify you once the water is blended and is below the nitrate MCL.

# **Secondary Notification Requirements**

Upon receipt of notification from a person operating a public water system, the following notification must be given within 10 days [Health and Safety Code Section 116450(g)]:

- SCHOOLS: Must notify school employees, students, and parents (if the students are minors).
- RESIDENTIAL RENTAL PROPERTY OWNERS OR MANAGERS (including nursing homes and care facilities): Must notify tenants.
- BUSINESS PROPERTY OWNERS, MANAGERS, OR OPERATORS: Must notify employees of businesses located on the property.
