CANCELLATION OF BOIL WATER NOTICE

September 23, 2025

Lake of the Woods Mutual Water Company (1510023)

Impacted Customers in South Pressure Zone

On September 21, 2025, the customers of Lake of the Woods Mutual Water Company (LOW MWC) in the **South Pressure Zone of Lake of the Woods from the corner of Lakeview Drive and Lakewood Drive by the Catholic Church, up Paige and part of Lakeview Drive at the top part by Lakeview Terrace, and some of Crable** were notified of the need to boil/disinfect all tap water used for drinking and cooking purposes from September 21, 2025 until further notice. The precautionary Boil Water Notice was issued due to a water main leak in the South Pressure Zone. LOW MWC temporarily shut down Wells 04 & 06 to repair the leak. After completing the repair & restoring the pressure in the distribution system on **September 21, 2025**, two (2) bacteriological samples were collected from the distribution system on **September 22, 2025**, and both samples tested absent for total coliform bacteria.

The LOW MWC in conjunction with the State Water Resources Control Board, Division of Drinking Water has determined that, through comprehensive testing of the water, your water is now considered safe to drink. **It is no longer necessary to boil your tap water or for you to consume bottled water.**


